Sealed Item Rate Tender is invited in Two Bid system on behalf of the Director, CDFD from the working contractors of CPWD, Railways, MES, State PWD, State R & B, Central / State Government / Autonomous bodies in respect of the work as detailed below up to **15:00 Hours on 12-08-2022.**

1. **Name of Work:** “Providing Aluminium Partition work for Pediatrics lab at 5th Floor Laboratory Building, Uppal, Hyderabad.”
2. **Scope of Work:** Providing Aluminium Fabrication work for partitions / cabins with glass / board for the Pediatrics Rare Genetic Disorder lab and its activities, False ceiling.
3. Details of Tender:

Tender Cost and EMD to be submitted in the form of Demand Draft only drawn from any nationalized bank favoring “THE DIRECTOR, CDFD, Hyderabad”.

4. Tender document is not transferable.
5. Tenders shall be opened in presence of tenders who may present at 15:30 hrs. on the last date for submission of tender at CDFD, Laboratory Campus, Inner Ring Road, Uppal, Hyderabad.
6. The site of the work is located at Experimental Animal Facility, CDFD Laboratory Complex, Inner Ring Road, Opp. to Metro rail pillar no.846, Uppal, Hyderabad – 500 039.
7. Tender Validity shall be 60 days from the last date of submission of tender.
8. All Tender documents attached with this tender enquiry are sacrosanct for considering any offer as complete offer.

Instructions to Bidders (ITB)

1. Before filling in the tender, the tenderer will have to check up all the tender documents and will have to get immediate clarifications from the CDFD on any point that he feels is vague or uncertain. No claim/damages or compensation will be entertained on this account.
2. The Technical Bid shall contain the following:
 - i) Duly signed Technical Tender Document Comprising NIT, ITB, Letter of submitting the tender, Special conditions of contract, Drawings and Approved make's list.
 - ii) Tender Cost and EMD in the form of demand draft.
 - iii) Documentary evidence for Eligibility as per eligibility criteria.
 - iv) Other Information / documents as indicated in NIT.
 - v) Any other information, tenderer may like to submit reflecting their credentials.
3. The price schedule shall contain the duly filled in price schedule.

Tenderer shall quote rates both in figures and words. He shall also work out the amount for each item of work and write in both figures and words. On check, if there is any difference between the rates quoted by the tenderers in the words and figures are in the amount worked out by them / him, the following procedure shall be followed.

 - a) When there is a difference between the rates in figures and the words, the rates which correspond to the amounts worked out by the tenderer shall be taken as correct.
 - b) When the amount of an item is not worked out by the tenderer or it doesn't correspond with the rate written either in figure or in words, the rate quoted by tenderer shall be taken as correct.
 - c) When the rates quoted by the tenders in figures and in words tally but the amount are not worked out correctly. The rates quoted by the tenderer shall be taken as correct and not the amount.
 - d) Except writing the rates and amount, the tenderer should not write any conditions or make any changes, additions, alterations and any modifications in the printed form of tender. Tenderers who are desirous to offer rebate, the same should be brought out separately in the covering letter and submit along with the tender.
4. **Eligibility Criteria:** The bidder shall meet the following eligibility criteria and submit the documentary evidence in the Technical Bid. The bid received without documentary evidence and not meeting the eligibility conditions shall summarily be rejected and their price bids will not be considered.
 - i) Tenderer should have valid registration with CPWD/Railways/MES/State PWD/State R&B, Central / State Government / Autonomous bodies and submit the copies of the same.
 - ii) Copies of attested IT returns submission for the last three financial years.
 - iii) **Work Experience:** The tenderer should have satisfactorily completed in the last seven years in his own / firm name at least one similar nature of work cost not less than of **₹5.05 Lakhs** or two similar works of each cost not less than **₹3.79 Lakhs** or three similar works costing not less than **₹2.52 lakhs**. Similar nature of work means Interior Works including of Aluminium Fabrication work in partitions/cabins/doors.
 - iv) Certificate of Registration for Goods and Services Tax (GST).

The tenderer should submit the details of such completed works, in support of having completed these works, the tenderer should submit copies of the completion certificates from the owner companies indicating the name of work, the description of work done by the tenderer, value of contract executed by the bidder, date of start, date of completion (contractual and actual), value of material supplied by the client.

4. **Earnest Money Deposit (EMD):**
 - i) The EMD mentioned against the above work shall be furnished in the form of Demand Draft in favour of "The Director, CDFD, Hyderabad" from any Nationalized Bank. The EMD of unsuccessful Tenderer shall be returned after evaluation of Tender.
 - ii) Tenders received without EMD will not be considered.
 - iii) The firms registered with NSIC / MSME, if any, are exempted from payment of EMD and Tender Cost subject to submission of valid documentary proof.
 - iv) The EMD amount will be forfeited if the successful tenderer fails to sign/execute the formal agreement within one week from the date of such intimation or fails to commence the work as per the work order.
 - v) The EMD of successful Tenderer shall be returned after receiving the Performance Guarantee.
5. **Defects Liability Period:** Six (6) months from the date of completion of work.
6. **Compensation for delay in execution:** The contractor shall pay as compensation an amount of equivalent to 1% (one percent) per week on the total value of unfinished / uncompleted work, subject to a maximum 5% of the tendered value of work, as compensation / penalty amount to the CDFD.
7. **Performance Guarantee and Security Deposit:** The successful tenderer has to submit performance guarantee for an amount of 5% of his / their tendered amount in the form of DD. This Performance Guarantee / Security Deposit will be returned to the contractor after satisfactory completion of the Defects Liability Period, providing the work has been carried out in accordance with agreement provision and the same is not forfeited for any reason.
8. CDFD does not bind itself to accept the lowest or any other tender and reserves the authority to reject any or all tenders without assigning any reason. All the tenders, in which any of the prescribed conditions are not fulfilled or incomplete, in any respect, are liable to be rejected.
9. This Tender Enquiry Form shall form the part of the Contract Document.
10. The Director, CDFD reserves the right to postpone the tender issue date, submission / opening date and to accept or reject any or all tenders without assigning any reasons.
11. Tender completed in all respects shall be submitted as per the instructions given in the General Conditions forming part of the tender document.
12. The successful tenderer on the acceptance of his tender by CDFD shall within one week from the stipulated date of start of the work sign the formal contract.
13. The tenderer shall sign all the pages of the tender documents and other documents submitted by him along with the tender.
14. Validity of Tender shall be 60 days from the last date for submission of Tender.
15. The tenderer should ensure that amounts quoted should appear only in the price schedule document and nowhere else, otherwise, the tender is liable to be rejected.
16. Director, CDFD reserves the right of accepting the whole or part of any tender and tenderer shall be bound to perform the same at the rate or amount quoted.

17. The successful tenderer shall be issued Letter of Intent for award of work. Acceptance of this letter shall be a binding of contract along with the contractors bid.
18. Diagrams shown in the document are indicative.
19. The General conditions of contract of CPWD (GCC 2020) with all amendments shall be applicable and form part of agreement.
20. All works shall be executed confirming to CPWD specifications 2019.
21. The rates shall be quoted inclusive of all taxes except GST and GST rate shall be quoted separately in the price bid for complete item work as such noting extra shall be payable. Necessary Income tax shall be deducted as per rules in force.
22. Time is essence of the contract. In order to complete the work within the schedule time the tenderer is required to submit a detailed programme chart for various activities.
23. Tenderers are advised to visit the site before quoting for better appreciation. For site visit please contact Incharge – Civil Engineering, Inner Ring Road, Uppal, Hyderabad - 500 039.
24. Income Tax and Goods and Services Tax (GST): Income tax shall be deducted at source as applicable by CDFD from the contractor's interim and final bill payments as required by law. GST shall be paid extra as per the applicable rule.
25. Water and Power Supply: One water point and electrical point power will be made available by CDFD to the contractor for the work. The contractor should make own arrangement for extending upto work area.
26. Method of submission of Tender:

The tender has to be submitted in three cover system as follows:

- a) First Sealed cover shall contain the EMD and the Technical Bid, and super-scribed as "Earnest Money Deposit (EMD) and Technical Bid for the work "Providing Aluminium Partition work for Pediatrics lab at 5th Floor Laboratory Building, Uppal, Hyderabad
- b) Second Sealed cover shall contain the duly filled and signed Price Bid and super-scribed as "Price Bid for "Providing Aluminium Partition work for Pediatrics lab at 5th Floor Laboratory Building, Uppal, Hyderabad."
- c) Third Sealed cover shall contain both indicated at (a) and (b) above and duly super-scribed "Providing Aluminium Partition work for Pediatrics lab at 5th Floor Laboratory Building, Uppal, Hyderabad."
- d) Sealed cover have to be addressed to The Director, CDFD, Inner Ring Road, Uppal, Hyderabad – 500 039. The sealed tender at any cost should not be handed over to any person.

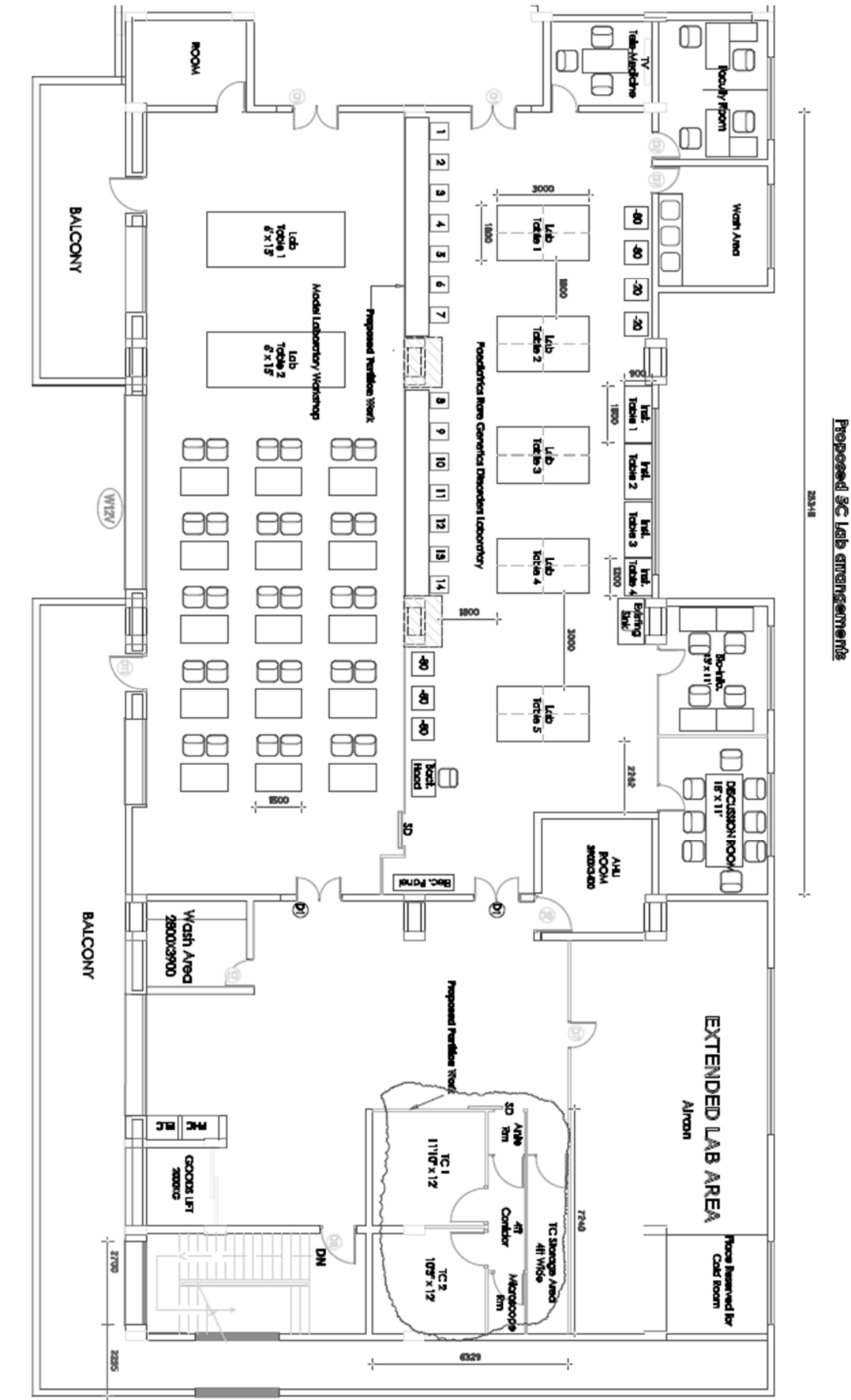
