#### Reasons for Disqualification:

##### 1. M/s. Oscar Ultra Sonics Pvt. Ltd.

- No Manual tuning
- No indication of the amount of energy that is being delivered
- Manufacturer indicated it will be provided but item was not available with demo piece
- Not digital. Only analog control dial for adjustment of amplitude or intensity
- No Energy Monitor and No Amplitude indicator
- The Sonicator is extremely heavy and space consuming, difficult to programme, lack of pause button, subtle noise from the sonicator while not in use.

- Submitted only 1 Purchase Order Copy against 2 Nos. and not meeting the Eligibility Criteria as per Tender.
